



# On-Campus Housing Immunization Protocol

Arizona Western College requires all student and staff living on campus to provide documentation that they have the following immunizations:

Vaccine	Required Doses
MMR (Measles, Mumps, Rubella)	2
Varicella (Chickenpox)	1
Td (Tetanus, Diphtheria)	1
Hepatitis A	1
Hepatitis B	1
Meningitis (Meningococcal ACWY)	1
Polio	1

You must submit proof of immunization to the Residential Life Office prior to residing on campus.

We will accept photocopies of official immunization records from your health care provider's office or records from your high school.

If you do not have vaccine records, please utilize the **On-Campus Housing - Proof of Immunization Compliance** form located under the forms section at [azwestern.edu/housing](http://azwestern.edu/housing). Your health care provider's signature is required.

If you choose to send your records electronically (fax or email), you **do not** need to submit additional hardcopies.

On any records the you submit, please include the following: **your name, AWC ID number, and date of birth.**

It is important to ensure your records show your name, date of birth, the month / day / year when each vaccination was received, and the medical personnel or facility that administered the vaccine. Illegible information may result in your records not being accepted.

According to the ACOP and the American College Health Association, **other recommended immunizations include:**

- Influenza Vaccine
- Human Papilloma Virus (HPC) Vaccine
- Pneumococcal Vaccine
- COVID-19 Vaccine
