AJS 201 CRIMINAL JUSTICE CRIME CONTROL POLICIES AND PRACTICES

Credit Hours: 3 Lec 3

PREREQUISITE: AJS 101 and ENG 101 or 107

COURSE DESCRIPTION

Explore the assumptions behind crime pattern theory, crime opportunity structures, and routine activities approach.

1. COURSE GOAL

- 1.1 Examine the concepts of environmental criminology.
- 1.2 Discuss situational crime prevention strategies, problem-oriented crime control approaches, “hot spots” policing, defensive space, and crime prevention by using environmental designs.

- 2.1 Summarize six (6) major crime prevention/environmental theories.
- 2.2 Distinguish between the environmental perspective and traditional theories of criminality.
- 2.3 Explain the uneven distribution of crime in American society.
- 2.4 Describe the four (4) stages involved in the SARA model.
- 2.5 Identify and analyze specific crime problems using environmental frameworks.
- 2.6 Use theory to design crime control strategies.
- 2.7 Discuss the major criticisms and ethical concerns relating to environmental crime prevention.
