

# Nursing Assistant Program (AHE 130)

This course focuses on applying client self-care concepts and basic procedures relative to the fundamentals of nursing, communication, nutrition, anatomy and physiology, medical terminology, legal/ethical issues, and aging. The concepts and procedures are introduced in the classroom and practiced in the college laboratory before implementation under faculty supervision in a clinical setting. This course prepares the learner for the state examination to become a certified or licensed nursing assistant.

**\*The Arizona State Board of Nursing requires evidence of citizenship or nationality for state certification or licensure (CNA, LNA). \***

**Course Length:** Fall/Spring – 8 & 16 weeks, Summer– 8 weeks

## **Application Requirements:**

- A score of 219 or higher on the Accuplacer Reading Course Placement Test **OR** Grade C or higher in ENG 090 **OR** 75% or higher on the Hesi A2
- Grade C or higher in MAT 081 **OR** 75% or Higher on Hesi A2 **OR** Accuplacer Math Placement into Mat 081
- CPR certification – must be Healthcare Provider BLS American Heart Association
- Current Arizona DPS Fingerprint Clearance Card
