5. Remarks from Dr. White at conclusion of Committee meeting

- a. Impressed at the work that is being done but he believes the work being done in regard to the new WI 3-Year Assessment Plan is more important than the WCC realizes.
- b. Reaffirmed the integrity of the 3-year assessment plan that the WCC created last semester.
- c. Does not feel the WCC has a sense of urgency that this assessment merits. Does not feel the WCC is prepared for what is coming.
 - i. To be responsive to the WI program, White suggested performing quick survey of faculty across the campus to understand how professors across campus perceive writing instruction and use, attitudes about student writing.
- d. Proverb, White's Law: Assess thy self or assessment shall be done unto thee.
- e. Have an assessment plan that will protect your program, like the 3-year assessment plan that was proposed which will contain both formative and summative data on the Student Learning Outcomes for WI.
