#### FAFSA

Completion of the FAFSA process (regardless of eligibility)

• Students with a completed FAFSA will receive the largest award amount, but **students with incomplete FAFSA or no FAFSA will still receive money** 

# <sub>2</sub> EFC

Estimated Family Contribution (EFC; based on FAFSA)

- Students who enroll full-time and have a completed FAFSA will receive \$1500 regardless of EFC
- Students enrolled less than full-time will receive amounts based on EFC

### <sub>3</sub> Credits

Number of credits enrolled

• Award amounts are determine based on full-time, ¾ time, ½ time, and less than ½ time. The more credits you enroll in, the more money you receive.
