Pursuant to A.R.S. § 8-431.03(A)(9), notice is hereby given to the members of the District Governing Board and the general public that the Arizona Western College District Governing Board will hold an EXECUTIVE SESSIONS MEETING, for discussion regarding the College's Information Technology Security Plans, Procedures, Assessments, Measures or Systems.

The meeting location will be open to the public at 4:45 pm at the latest.

The meeting will begin at no earlier than 5 pm in the Frances Morris Boardroom, on the Yuma Campus and through Zoom. The Board reserves the right to change the order of items on the agenda with the exception of public hearings. If the agenda includes an Open Call, members of the public will have no more than 3 minutes to speak. The time allotted for each speaker may be less than 3 minutes, depending on the number of individuals wishing to address the board at the meeting and the board president's determination of the total time available for open call at the meeting, given the other matters on the board's agenda. *In addition, if there are a number of people who wish to speak about the same issue and who have the same viewpoint about that issue, the board president may direct them to appoint a representative or representatives to speak for the entire group. Members of the board may not discuss items that are not specifically identified on the agenda but that are raised in Open Call. Matters raised during Open Call that are on the current board agenda may be discussed and/or decided by the board at the appropriate time on the agenda.

Pursuant to A.R.S. §38-431.03.A.2, A.3 and A.4, the Board may vote to go into Executive Session, which will not be open to the public, for legal advice concerning any item on the agenda to review, discuss and consider records exempt by law from public inspection, including the receipt and discussion of information or testimony that is specifically required to be maintained as confidential by state or federal law; or to consult with and instruct its attorneys regarding its position on contracts, litigation or settlement discussions. If indicated on the agenda, the Board may also vote to go into executive session, which will <u>not</u> be open to the public, to discuss specific agenda items.
