The Regular meeting will begin at 12pm am in the Frances Morris Board room in the 3C, College Community Center, at the Arizona Western College Yuma Campus, and through Zoom. Pursuant to A.R.S. § 38.431.02, notice is hereby given to the members of the District Governing Board and the general public that the Arizona Western College District Governing Board will hold an EXECUTIVE SESSION MEETING:

1. Executive Session Discussion- A.R.S. 38-431.03 (A)(3): Discussion or consultation for legal advice with the attorney or attorneys of the public body and A.R.S. 38-431.03 (A)(4): Discussion or consultation with the attorneys of the public body in order to consider its position and instruct its attorneys regarding the public body's position regarding contemplated litigation.
 - a. This executive session will discuss (1) a pending legal matter and (2) legal advice regarding personnel processes
2. A.R.S. 38-431.03 (A)(1) Personnel Matters - Discussion or consideration of employment, assignment, appointment, promotion, demotion, dismissal, salaries, disciplining or resignation of a public officer, appointee or employee of any public body, except that, with the exception of salary discussions, an officer, appointee or employee may demand that the discussion or consideration occur at a public meeting.
 - a. This executive session will include President Corr's annual performance appraisal including the employment contract and terms.
3. Pursuant to A.R.S. § 8-431.03(A)(9), for discussion regarding the College's Information Technology Security Plans, Procedures, Assessments, Measures or Systems.
