### **College Reports**

# Fiscal Year 2024 Arizona Auditor Report, Presented by Arizona Auditor General

Jean Marie Dietrich, CPA and Principal with the Arizona Auditor General's Office, and Carla Wall of Clifton Larson and Associates, presented the results of the annual audit for the Yuma/La Paz Counties Community College District (Arizona Western College) for the fiscal year ending June 30, 2024. The audit confirmed the College's continued strong fiscal stewardship with an unmodified ("clean") opinion on its financial statements and no findings of material weaknesses or significant deficiencies in internal controls. No new accounting policies were implemented during the period, and the audit identified no unusual transactions, disagreements with management, or compliance issues with applicable laws and regulations.

The audit also included testing of major federal programs, which accounted for 80% of AWC's total federal expenditures of \$24 million. These included \$17.6 million in student financial aid and \$1.6 million in WIOA program funding, both of which were found to follow federal requirements. Additionally, the Annual Budgeted Expenditure Limitation Report showed that AWC remained well within its statutory spending limit, with actual expenditures of \$53.2 million against a \$60.9 million cap, further underscoring the College's commitment to conservative and responsible budget practices. This report also presents no findings related to the District's control procedures associated with its IT systems and data.

# Student Government Association, Presented by Jorge Ramirez

Jorge Ramirez, Student Government Association (SGA) President, provided the student leadership report to the District Governing Board in advance of the spring commencement season. In his remarks, Jorge highlighted key initiatives and events hosted or supported by the SGA, reflecting student engagement, school spirit, and campus-wide collaboration. Notable recent events included the successful Sexual Assault Awareness Walk/Run held on April 30, the Enrollment Tour Club Mixer on May 12 to connect prospective students with campus clubs and services, and a spirited Cap Decoration Party on May 7 to celebrate graduating students. Looking ahead, Jorge noted the upcoming Commencement Ceremony on May 16 and reported on the recently concluded SGA elections, ensuring a smooth transition of leadership for the coming academic year. He closed with an expression of gratitude for the support of the Governing Board, faculty, staff, and student body throughout the year, emphasizing a strong sense of community and pride in student-led initiatives that contributed to campus life and student success.

## Faculty Senate Association, Presented by Dr. Emily Kerr

Dr. Emily Kerr, Professor of English as a Second Language, provided the Faculty Senate update for April 2025, marking her first report as the new Faculty Senate Representative to the District Governing Board. Dr. Kerr brings a depth of institutional experience to the role, having served as Faculty Advisor to the GSA Full Spectrum and as former Vice Chair of the Curriculum Committee. The 2025–2026 Faculty Senate Leadership was formally introduced, including Dr. Eric Lee as Faculty Association President and Dr. Kristine Duke as Vice President, with an inclusive group of faculty senators representing a broad array of disciplines and departments. The report highlighted recent faculty engagement in professional development and scholarship, including participation in the AZ Transfer Summit, TESOL 2025, and the Conference on College Composition and Communication. Dr. Deltrina Grimes, Professor of Music – Voice, was recognized for successfully defending her dissertation. Faculty and students also remained active in student engagement and community service, including club fundraising initiatives and participation in TEDxAWC event on April 25, led by Dr. Sara Amani. The report reflects ongoing faculty commitment to excellence in teaching, professional growth, and community involvement.

## Student of the Month, Presented by Bryan Doak and Professor Seth Minor

Sarah Ausbun, an Associate of Arts in Education – Secondary student, was honored as Student of the Month for her outstanding academic engagement and leadership. Nominated by faculty member Seth Miner from the Division of Business, Education, Social, and Behavioral Sciences, Sarah was recognized for her vocal participation, intellectual curiosity, and ability to elevate classroom discourse. A dedicated member of the Philosophy Club, she is known for her openness to differing perspectives and her thoughtful pursuit of truth. Beyond the classroom, Sarah balances her academic commitments with her role as a devoted mother, drawing inspiration from her son as she works toward her goal of becoming a high school math teacher. Her resilience, reflective mindset, and passion for learning exemplify the spirit of Arizona Western College students, making her a deserving recipient of this recognition. Additionally, Bryan celebrated Seth, who nine years ago was a featured Student of the Month at a Board Meeting. This full-circle recognition was celebrated by the Board and those in the room.

## AWC Foundation Status Report, Presented by Lori Stofft

The AWC Foundation provided a comprehensive update on its impact, leadership, and fundraising momentum in support of Arizona Western College's mission. Established concurrently with the college in 1963, the Foundation remains focused on student success through scholarships, programmatic support, and capital improvements. With a committed 11-member Board of Directors representing a range of professional sectors, the Foundation has continued progress on its strategic goals: increasing visibility, expanding donations, and deepening board engagement. Notable achievements include sustained growth across fundraising metrics—up to 154% growth in some areas—and a 39% increase in scholarship awards over the last two years, benefiting over 640 students annually.

Laura Knaresboro featured the scholarship emphasis, beyond traditional scholarships, the Foundation has invested in emergency support through the Gold Heart Endowed Fund, responding to critical student needs such as food, housing, prescriptions, and access to learning tools. Strategic partnerships have enabled the purchase of graphing calculators for South County students and supported academic excellence, including students achieving near-perfect ACT scores. AWC Foundation Board chair, Megan Scott, celebrated the Foundation's signature event, the Schoolhouse Soiree, continues to connect the community with students and donors, raising funds and awareness for initiatives such as the First Gen Center refresh and the Anatomage Table for healthcare education. Through intentional alignment with AWC's strategic priorities—including the \$1.2M library expansion project, the Foundation continues to play a vital role in expanding opportunity and enhancing the student experience.

Budgetary Considerations: The budget impact of this differential tuition fee is largely offset by increased enrollment, as the course will be more accessible to students utilizing Arizona@Work assistance and the QUEST Grant. The higher tuition rate for the CDL program in Parker reflects additional costs from the third-party vendor, associated with delivering this training. These include a higher per-student training fee and increased travel, lodging, and instructor compensation expenses required to offer the course at the Parker campus location.

Discussion confirmed this is the sole vendor servicing Yuma, La Paz and Mohave Counties to meet the demand the local workforces are asking for college hosted training.

## Summary:

Dr. Corr walked through his presentation reflecting on the 2024-25 year, his 9<sup>th</sup> year as President at AWC. His report highlighted significant institutional achievements from the 2024–2025 academic year. Student success remained a central focus, with a 31% increase in credentials awarded and a 19% rise in medical-related credentials. Enrollment growth continued strongly, with a 16% increase in the fall and a 4% increase in the spring, including notable gains at the Parker (12%) and Wellton (11%) locations. AWC was recognized as the fastest-growing community college in Arizona, with a nine-year growth rate of 919%, and Early College students now make up 25% of total enrollment.

Academic innovation was also emphasized, with the Entrepreneurial College posting a 29% increase in enrollment, securing \$9.57 million in grant funding, and launching 26 new courses along with 12 new programs and certificates. The AWC/NAU transfer partnership received national recognition as a top-ten model by the Aspen Foundation and Columbia University, with a new Transfer Center opened in March 2025. Fiscal stewardship remained a hallmark, with the College achieving a perfect Single Audit—no fiscal or IT findings—and strong recognition for the impact of the Entrepreneurial College and the institution's grant performance.

Organizational leadership and structural refinement were also presented. The College undertook administrative restructuring, including the elimination of one Vice President and one Dean role, Cabinet-level changes, and succession planning. A more directive approach to institutional decision-making was introduced, improving processes such as course scheduling. In La Paz County, strategic community partnerships expanded, including a \$500,000 contribution and \$250,000–\$300,000 in equipment donations from Onvida, a shared faculty arrangement with STEDY, and infrastructure collaboration with LETA and the Yuma Union High School District.

Institutional visibility and student culture remained strong, with national recognition for AWC's communications and marketing, a record-breaking year for the AWC Foundation, and three athletic teams advancing to NJCAA national tournaments. Looking ahead, President Corr expressed enthusiasm for his tenth year in office and acknowledged both the increasing pace of disruptive change and the uncertainties in state and federal funding. He reaffirmed AWC's strong position for sustained, long-term growth and continued community impact.

The District Governing Board commended Dr. Corr and the College leadership team for their exemplary leadership and the College's strong reputation in community college education statewide. The Board noted the growth of partnerships and quality programming as evidence of the College's forward-thinking approach, attracting attention and admiration from other Community College Boards.
