Special Meeting: 2023-2024 College Budgets

(A.R.S. 15-1461 and 15-1461.01)

Dr. Daniel P. Corr welcomed the Board and confirmed that no public comments have been received for review or consideration by the District Governing Board or the College. He invited Ross Poppenberger to share budget overview for the proposed 2023/24 Budget.

The Arizona Western College priority-based budget utilizes the anticipated revenue from various sources that will be available to the College for delivery of educational services to the citizens of Yuma and La Paz Counties during 2023-24. The budget reflects an overall increase of 2.6%. This increase reflects an increase of 44.0% in state aid, a 34.8% increase in equalization aid, a 37.0% increase in Rural aid, a 4.6% increase in district levy, which includes a 1.91% increase in the levy tax rate, and a \$2 increase in tuition with no change in FTSE. Other revenues include a 35.3% increase in food service revenues offset by a 67.7% decrease in bookstore revenues. The assessed valuation within the District increased 5.8%, of which 2.6% was due to new construction.

Highlights of the Budget include a 5% increase in salaries for all full-time employees and a .22% increase in the contribution rate for A.S.R.S. Capital projects were addressed to continue to provide the District with environmentally safe and sound facilities and enhance processes through software purchases.

This budget includes using the Series 2021 and 2022 bond proceeds and institutional funds to complete the DeAnza Residence Hall and the Matador Activity Center ("MAC") construction projects. This budget includes using regional grant funding and institutional funds for the Law Enforcement Training Academy ("LETA") construction. Sunsetting federal and state grant funds to students and the institution in response to the coronavirus pandemic are included in the Fiscal Year 2023-2024 budget. Lastly, this budget includes contingencies for anticipated needs.

Since presenting the Budget in April 2023, the College is in receipt of funding from the State Budget and Arizona Commerce Authority to continue to serve student programming.

Mr. Booth sought feedback from Board members about the Budget.

Dr. MacFarland shared his comments about how this budget reflects the College's commitment and response to the student-driven increase of services to students and growth in respond to the demand by students in the growing economy within the District, not increasing budget for the college's own sake. Growing to the investment in employees honoring the investment in the people of the college.

Through the work by the Small Business Development Center (SBDC), the team has been impacting La Paz and Yuma County through Business Development planning and free business counseling. She welcomed SBDC Director, Crystal Mendoza, who presented the impact of Arizona's SBDC Network which focuses on the help to launch, grow and sustain small businesses in Arizona as Arizona's largest most comprehensive and accessible statewide source of assistance for small businesses in every stage of development. The SBDC-AWC Open Counseling Sessions are regularly scheduled in Yuma, Somerton, Wellton, San Luis and Parker which complement the 'Please Buy Local' Campaign, noticeable within the community through the display of a yellow flag adorned with a heart. Between October 2022 to February 2023, over 527 clients were supported, 157 jobs created, 19 Business' started and a total sales growth of \$14,153,742 was tracked. SBDC is making an impact supporting the atlarge District and communities.
