PREREQUISITE: ACC 100 or higher level accounting course

COURSE DESCRIPTION

A course introducing the student to common federal income tax returns for individuals in a variety of situations.

COURSE GOALS

- 1.1 Acquaint the student with forms and schedules to meet individual federal tax return requirements.
- 1.2 Introduce the student to forms and schedules filed by partnerships and corporations.

- 2.4 calculate tax credits.
- 2.5 report payroll taxes.
- 2.6 understand the effect of retirement, other tax deferred plans, and annuities on personal income tax.
- 2.7 calculate special property transactions.
- 2.8 complete other individual income tax calculations.
- 2.9 review corporate and partnership returns.
