ACC 220 INTRODUCTION TO COST ACCOUNTING

Credit Hours: 3 Lec 3

PREREQUISITE: ACC 212

COURSE DESCRIPTION

A course designed to allow the student to review concepts introduced in managerial accounting. Students will focus on different types of cost accounting, cost behaviors, cost analysis for management decision making.

- 1.3 Graph and interpret Cost Volume Profit Analysis
- 1.4 Estimate costs using various methods
- 1.5 Differentiate between job and process costing methods
- 1.6 Allocate overhead using activity-based costing, plant-wide, and departmental methods
- 1.7 Define methods available to managers for controlling costs
- 1.8 Complete budgets and report performance
- 1.9 Analyze variances between standard and actual costs
- 1.10 Utilize transfer pricing between different departments and divisions in a company
- 1.11 Analyze non-financial performance measures and management uses of the data

- 2.2 define cost behavior for fixed, variable, and mixed costs.
- 2.3 use Cost Volume Profit Analysis to understand cost structures.

- 2.5 analyze costs using job and process costing methods and the effect on income.
- 2.6 apply plant-wide, departmental, and activity-based costing methods.
- 2.7 explain management methods used for controlling costs.
- 2.8 prepare budgets and report performance.
- 2.9 report variances between standard and actual costs.
- 2.10 explain the effect on income reported for departments and divisions after applying transfer pricing.
- 2.11 analyze a company's performance using non-financial performance measures
