ACR 101 AIR CONDITIONING AND REFRIGERATION I

Credit Hours: <u>3</u> Lec <u>2</u> Lab <u>2</u>

PREREQUISITE: None

NOTE: Concurrent enrollment in ACR 103 highly recommended

COURSE DESCRIPTION

Introduction to the field of air conditioning and refrigeration, use of hand tools, materials, and related nomenclature of the component parts of a system and their relationship to and function within the system are stressed.

1. <u>COURSE GOAL</u>

This course prepares the student to have a thorough knowledge of the basic air conditioning and refrigeration cycle, the use of HVAC tools and the proper handling of HVAC equipment.

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 discuss the history of air conditioning and refrigeration.
- 2.2 demonstrate the ability to use HVAC tools properly.
- 2.3 demonstrate the ability to use HVAC equipment properly.
- 2.4 describe the various types of HVAC systems in use today.
- 2.5 describe the operation of a basic refrigeration cycle.
- 2.6 demonstrate the basic knowledge of silver brazing.
- 2.7 explain the function of individual HVAC components.

3. <u>METHODS OF INSTRUCTION</u>

4. <u>LEARNING ACTIVITIES</u>

- 4.1 Class and lab policy

- 4.4 Drawing and interpreting wiring diagrams
- 4.5 Mastering the proper use of hand and power tools
- 4.6 Proper handling of equipment

5. <u>EVALUATION</u>

Evaluation is based on the student ability to perform the objectives identified for this course. Written examinations will be given bi-weekly during the semester. There will be several lab and field projects during the semester.

Grades for the semester will be arrived at as follows:

- 5.1 Written exams will be graded on a point system; the number of points will be based on the number of questions.
- 5.2 Homework assignments will be graded on a point system
- 5.3 Lab assignments will be graded based on 4 steps:
 - Step 1: Understanding work to be performed
 - Step 2: Following safe work procedures

Step 3: Ability to perform assigned tasks as per HVAC industry standards

Step 4: Quality and quantity of work performed in the allowed time as determined by the instructor and based on the HVAC industry standards.

6. <u>STUDENT RESPONSIBILITIES</u>

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
- 6.2 If a student is unable to attend the course or must drop the course for any reason, it will be the responsibility of the student to withdraw from the course. Students who are not attending as of the 45th day of the course may be withdrawn by the instructor.
