PREREQUISITE: ACR 103

COURSE DESCRIPTION

The theory, installation practices, and servicing of heating systems, including the study of equipment sizing, equipment selection, energy conservation, natural gas, propane, electric heating systems, and the study of alternative fuels.

Prepare the student to install and service heating systems.

- 2.7 explain and demonstrate the procedure for installing a heating system.
- 2.8 demonstrate a complete knowledge of all safety procedures.
- 2.9 describe different fuels and equipment used in a heating system, equipment sizing and alternative fuels.
