ACR 213 LIGHT COMMERCIAL SYSTEMS

Credit Hours: 3 Lec 2 Lab 2

PREREQUISITE: ACR 102

COURSE DESCRIPTION

The theory, installation practices, and servicing of light commercial refrigeration systems with a study of equipment sizing, wiring diagrams, and control systems, reach-in coolers and freezers, open case systems, and heat reclaim systems.

1. <u>COURSE GOAL</u>

To enable the student to acquire knowledge of light commercial systems based on the current industry standards and practices. Upon satisfactory completion of this course, the student will be able to enter the light commercial refrigeration industry.

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1. explain the theory of light commercial refrigeration systems.
- 2.2. diagnose and service a reach-in cooler system.
- 2.3. diagnose and service a reach-in freezer system.
- 2.4. diagnose and service an open case freezer and cooler.
- 2.5. describe the operation of a multi-case refrigeration system.
- 2.6. describe the operation of a heat reclaim system.
- 2.7. describe and perform troubleshooting techniques.
- 2.8. diagnose and service light commercial control systems.

5. <u>EVALUATION</u>

Evaluation is based on the student's ability to perform the objectives identified for this course. Written examinations will be given bi-weekly during the semester. There will be several lab and field projects during the semester.

Grades for the semester will be arrived as follows:

- 5.1 Written examinations will be graded on a point system. The number of points will be based on the number of questions
- 5.2 Homework assignments will be graded on a point system
- 5.3 Lab assignments will be graded based on 4 steps:
 - Step 1. Understanding work to be performed

- Step 2. Following safe work procedures
- Step 3. Ability to perform assigned tasks as per HVAC industry standards
- Step 4. Quality and quantity of work performed in the allowed time as determined by the instructor and based on HVAC industry standards.

6. STUDENT RESPONSIBILITIES
