### ARIZONA WESTERN COLLEGE SYLLABUS

AHE201 HUMAN PATHOPHYSIOLOGY

Credit Hours: 4 Lec 4

PREREQUISITES: BIO201 and BIO202

### **COURSE DESCRIPTION**

Pathophysiological processes in humans as a foundation for the understanding of alterations in health. Survey of major disease processes of the human body systems. Includes terminology, causes, signs, symptoms, diagnosis, treatment, and special considerations. Information: This course is a prerequisite for the concurrent Associate Degree/Baccalaureate Degree Nursing program through Arizona Western College and Northern Arizona University.

### 1. COURSE GOAL

Supply the student with the educational resources for understanding pathophysiology processes in humans.

### 2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 Utilize medical terminology as it applies to the pathophysiologic basis for alterations in health.
- 2.2 Describe the mechanisms of normal and altered anatomic structure and physiological function within the human body.
- 2.3 Describe the pathophysiology of the cardiac, respiratory, gastrointestinal, hepatobiliary, pancreatic, renal, endocrine, reproductive, skeletal and muscular, immune, and nervous systems.
- 2.4 Identify and describe approaches to treatments of various diseases based on current medical science and clinical practice.
- 2.5 Outline disease awareness and infection control including general prevention of diseases, healthy life style and awareness and how infection is spread as well as prevention methods.
