#### **AJS 193 VICTIMOLOGY**

Credit Hours: 3 Lec 3

PREREQUISITE: None

#### **COURSE DESCRIPTION**

The study of victims, also called Victimology, explores various types of crimes, reasons why individuals are victimized, and the level of involvement from the criminal justice system in victims' issues.

Understand how individuals are victimized and how the criminal justice system responds to the victimization.

### 6. STUDENT RESPONSIBILITIES
