## AJS 242 COMMUNITY CORRECTIONS

Credit Hours: 3 Lec 3

PREREQUISITE: None

COURSE DESCRIPTION

Examines community treatment in the correctional process and the selection and release of both adults and juveniles under the supervision of probation and parole.

1. COURSE GOALS

- 1.1 Describe the role of Probation, Parole and Community Corrections within the Criminal Justice System.
- 1.2 Define features of the Federal, State and Juvenile Systems in the areas of Probation, Parole and Community Corrections.
- 1.3 Trace historical development of Probation and Parole.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 identify differences evidenced between theory and practice in the systems of probation and parole (within functions of supervision, investigation, revocation)
- 2.2 compare and contrast probation and parole process.
- 2.3 identify common methods employed in the classifying of offenders for eligibility in various components of the system, adult and juvenile.
- 2.4 examine officer-to-officer interaction; its influence on system effectiveness, recruitment criteria and professional development of officers

6. STUDENT RESPONSIBILITIES
