AJS 260 PROCEDURAL CRIMINAL LAW

Credit Hours: 3 Lec 3

PREREQUISITE: None

NOTE: AJS 101 recommended

COURSE DESCRIPTION

Provides the student with an understanding of the rationale underling major court holdings, the procedural requirements that stem from these holdings, and their effect on the daily operations of criminal justice system.

1. COURSE GOALS

1.1 Understand the judicial system as it relates to the law enforcement officer and the criminal justice system.

1.2 Understand the major constitutional decisions that affect the criminal justice system.

1.3 Understand the procedure of the State of Arizona and how it affects the judicial system and the law enforcement officer within it's jurisdiction.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

2.1 Identify the time limits associated with each of the following phases of the criminal cases:

- a) initial appearance;
- b) Grand Jury/preliminary hearing in custody;
- c) Grand jury/preliminary hearing not in custody.

2.2 Identify the nature and purpose of each of the following process in criminal cases:

- a) complaint;
- b) information;
- c) initial appearance;
- d) Grand Jury/preliminary hearing;
- e) bail, bond;
- f) arraignment;
- g) pre-trial court hearing (omnibus hearing);
- h) case preparation (Officer-Prosecutor relationship);
- i) discovery;
- j) plea agreement (bargaining);
- k) adult diversion;
- l) juvenile transfer;
- m) trial;
- n) sentencing;
- o) pre-sentencing report/hearing;
- p) appeals;
- q) venue; and
- r) jurisdiction

2.3 Identify the jurisdiction and primary responsibility of each of the following courts in the Arizona Court System:

- a) Municipal;
- b) Justice;
- c) Superior;
- d) Court of Appeals; and
- e) Supreme Court.

2.4 Identify the jurisdiction and primary responsibility of the following courts that comprise the Federal Court System:

- a) District Courts;
- b) Court of Appeals; and
- c) Supreme Court.

6. STUDENT RESPONSIBILITIES
