AJS 276 CRIMINALISTICS: BIOLOGICAL EVIDENCE Credit Hours: _3__ Lec _3__

PREREQUISITE: None

COURSE DESCRIPTION

The scientific analysis and examination of biological evidence with emphasis on collection and preservation of evidence. Topics discussed include blood, drugs, alcohol, hair, fibers and topics of special interest in criminalistics.

1. <u>COURSE GOAL</u>

Introduce student to the field of forensic science with a focus on forensic biology.

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 describe the various characteristics of hair and fibers.
- 2.2 identify the characteristics of common drugs, narcotics, hallucinogens and depressants.
- 2.3 describe the physiological characteristics of alcohol.
- 2.4 describe the use of the intoxilyzer and other breath analyzing equipment.
- 2.5 describe the general characteristics of body fluids.
- 2.6 explain the various stages of decay.
- 2.7 explain how evidence can be obtained from protists, fungi and plants.
- 2.8 explain how evidence can be obtained from invertebrates and vertebrates.

6. <u>STUDENT RESPONSIBILITIES</u>
