## COURSE DESCRIPTION

The livestock and poultry industries including applications of scientific principles, marketing, and selection are emphasized.

# 1. COURSE GOAL

This course prepares learners for employment in the animal industry by providing a working knowledge of meat, milk, eggs, and wool production utilizing the following species: poultry, swine, sheep, goats, and cattle (dairy and beef).

- 2.1 identify the sources of financial support for livestock enterprises.
- 2.2 describe the role of animal agriculture in the American economy, giving its significance and historical background.
- 2.3 identify and discuss the breeding and reproductive systems of common livestock.
  - 2.3.1 describe animal inheritance.
- 2.4 explain animal nutritional needs and feed requirements for major classes of livestock.
  - explain the comparative factors of the different digestive systems of animals and their adaptability in the agricultural economy.
- 2.5 discuss the marketing and processing functions of animal agriculture and know their importance in the economy.
- 2.6 identify the commercially important breeds of livestock, their developmental physiology and their regional significance.
- 2.7 discuss the role of genetic engineering in the animal industry.
- 2.8 identify careers available in the livestock industry.
- 2.9 identify the criteria used when evaluating live animals.
- 2.10 evaluate livestock carcass composition.
- 2.11 discuss food safety issues affecting humans and animal agriculture.
- 2.12 discuss companion animals, wildlife, and zoology, and their role in animal agriculture.

# 6. STUDENT RESPONSIBILITIES
