ANS 130 LIVESTOCK PRODUCTION MANAGEMENT

Credit Hours: 3 Lec: 2 Lab: 3

PREREQUISITE: None

COURSE DESCRIPTION

This course develops entry-level skills in the production and management of livestock and companion animals. It includes skill development in facility design and management of breeding systems in cattle, horse, sheep, goat, swine and companion animals. Learners will learn how to handle livestock appropriately. There will be an online component covering Institutional Animal Use Care and Use Committee (IACUC) training and certification.

1. COURSE GOAL

This course prepares learners for employment in the animal industry by providing working knowledge of animal management, breeding and development of beef, swine, sheep, goats, companion animals and horses.

2. **OUTCOMES**

Upon satisfactory completion of this course, students will be able to:

- 2.1 explain the operation of livestock facilities and the related animal handling equipment.
- 2.2 identify species' specific breeding systems, practices.
- 2.3 identify the key aspects of animal disease and their control practices.
- 2.4 identify and describe the proper management practices of breeding animals, feeder animals, and work animals.
- 2.5 identify and employ the basic methods of animal selection and animal grading.
- 2.6 discuss the role of artificial insemination and genetic engineering in the animal industry.
- 2.7 demonstrate appropriate handling and restraint methods for various species of animals.
- 2.8 identify tools and equipment used for working with and on various species of animals.
- 2.9 identify and discuss flight zones and appropriate working facilities for various species of animals.
- 2.10 understand IACUC protocol and be able to explain how IACUC plays a role in current animal research.
