ANS 240 FEEDS AND FEEDING

Credit Hours: 4 Lec 3 Lab 3

PREREQUISITE: ENG 101 or 107

COURSE DESCRIPTION

Selection, evaluation, classification, and use of feeds for specific purposes in animal nutrition to include the element of nutrition, commonly used feeds, nutritive requirements, feed processing, and practical methods of feeding different classes of livestock and evaluation of livestock carcasses to determine nutritional needs.

1. COURSE GOAL

This course prepares learners for employment in the animal industry by providing working knowledge of animal nutritional needs and feed requirements for major classes of livestock. Learners will also have a understanding of how nutrition affects carcass yield.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 distinguish between ruminants and non-ruminants and select feedstuffs appropriate to each class of livestock.
- 2.2 describe the functions of each of the six general classes of nutrients and their common sources.
- 2.3 determine the proper amounts of feed and water to feed various classes of livestock.
- 2.4 determine relative nutrient value and classes of feedstuffs.
- 2.5 interpret feed tags, labels, and feed analysis reports.
- 2.6 develop and balance rations and calculate cost.
- 2.7 determine the equipment needed to feed livestock.
- 2.8 recognize problems associated with over or under feeding.
- 2.9 identify the pros and cons of using growth stimulants
- 2.10 observe and handle feed and equipment safely.
- 2.11 understand state and federal laws.
- 2.12 evaluate livestock live.
- 2.13 evaluate livestock carcass composition and how proper nutrition affects the animal carcass.
