# ARB 096 BEGINNING CONVERSATIONAL ARABIC II

Credit Hours: 3 Lec: 3

PREREQUISITE: ARB 95, or equivalent proficiency as determined by instructor

# **COURSE DESCRIPTION**

A conversational course for students with prior familiarity of Arabic language and culture of the Arabic-speaking countries.

### 1. COURSE GOALS

- 1.1 Develop a solid foundation for listening and speaking Arabic words.
- 1.2 Read simple paragraphs and understand the main ideas.
- 1.3 Initiate conversations on a number of daily life topics
- 1.4 Develop solid understandings of Arabic sentence structure.
- 1.5 Articulate with difference between written formal and several Arabic spoken dialects

#### 2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 Communicate in highly predictable everyday situations.
- 2.2 Process and replicate oral information at low novice level.
- 2.3 Produce limited memorized material in simple statements or questions.
- 2.4 Demonstrate understandable pronunciation skills when speaking.
- 2.5 Recognize and explain everyday cultural patterns.
- 2.6 Present and articulate personal information.

## 3. METHODS OF INSTRUCTION

- 3.1 Total Physical Response (TPR), along with the audio-lingual and natural approach
- 3.2 Discussions, readings, repetition of phrases, role playing, and oral and written drills
- 3.3 Viewing videos and listening to audio

## 6. <u>STUDENT RESPONSIBILITIES</u>
