PREREQUISITE: None

COURSE DESCRIPTION

A survey history of Western European art from Paleolithic to the late Gothic period along with primitive art from non-Western sources.

1. **COURSE GOALS**

- Acquire a demonstrable understanding of the cultural and stylistic trends in art. 1.1
- Develop the critical skills used in analyzing the relationship between form and content in the 1.2 visual arts.
- 1.3 Be prepared for subsequent study of art history.
