ART 102 BASIC DESIGN, 3 DIMENSIONAL Credit Hours: <u>3</u> Lec <u>2</u> Lab <u>4</u> SUN# ART 1115

PREREQUISITE: None

COURSE DESCRIPTION

The sculpture of Western and non-Western traditions, primitive to modern, provide the basis for this study of 3 dimensional design principles. The basics of modeling, carving, assembling, and mold making will be touched on. Both realistic and abstract works will be made using clay, foam core, plaster, and other materials. This course is a required foundation course for art majors and minors and is a prerequisite for upper division courses at most four-year colleges and universities.

1. COURSE GOAL

This course prepares learners to conceptualize in three-dimensional space.

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 explore various historical and current sculptural issues.
- 2.2 know basic tool handling and construction techniques.
- 2.3 translate ideas into three-dimensional forms.
- 2.4 participate in a group project.
- 2.5 document work with slides.

4. <u>LEARNING ACTIVITIES</u>

- 4.1 Slide lectures to introduce artists and various artistic concepts
- 4.2 Visual assignments based on slide lectures as part of class studio as well as homework
- 4.3 Journal: class notes, sketches in sequential order
- 4.3 Oral reports: 20th century sculptor, 15 min. with visuals
- 4.5 Participation in-group project
- 4.6 Prepare slide sheet for final review

5. <u>EVALUATION</u>

6. <u>STUDENT RESPONSIBILITIES</u>
