ART 111 DRAWING Credit Hours: _3__ Lec _2_ Lab _4_

PREREQUISITE: None

COURSE DESCRIPTION

Survey of fundamental technical and perceptual drawing skills. Emphasizes observation, pictorial organization (composition) and common drawing media. This foundational course is required for art majors and minors and is a prerequisite for advanced level courses at most four-year colleges and universities.

- 1.1 Learn to draw from direct observation
- 1.2 Learn to translate three-dimensional objects into a two-dimensional statement
- 1.3 Increase skill with compositional organization and spatial illusion

Upon satisfactory completion of this course, students will be able to:

- 2.1 Demonstrate skill with basic media and techniques
- 2.2 Accurately render models
- 2.3 Create visually cohesive images based on compositional concepts and analysis
- 2.4 Demonstrate knowledge of drawing concepts and vocabulary

6. <u>STUDENT RESPONSIBILITIES</u>
