ART 201 PAINTING 1

Credit Hours: 3 Lec 2 Lab 4

PREREQUISITE: None (ART-101 or ART-111 Recommended)

COURSE DESCRIPTION

Introductory level painting course. Emphasizes color theory, technique and composition.

- 1.3 Learn painting concepts and basic vocabulary

- 2.3 create visually cohesive images based on compositional concepts and analysis

6. STUDENT RESPONSIBILITIES
