ART 203 CERAMICS 1

Credit Hours: 3 Lec 2 Lab 4

PREREQUISITE: None

COURSE DESCRIPTION

A hands-on look at the history of the use of clay and how it leads to the development of contemporary ceramic art. Techniques covered will include primitive coiling, wheel throwing, modeling, and contemporary slab forming.

1. COURSE GOALS

- 1.1 Introduces students to important images and techniques of ceramics.
- 1.2 Helps students understand the development of kilns and glazes and their importance to the development of modern technology.
- 1.3 Provides an opportunity to use the ideas, vocabulary and basic methods of the visual arts.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 demonstrate their knowledge glazes by applying to work they have created.
- 2.2 demonstrate their understanding of the basic methods of ceramics by executing the required "hands on" projects.
- 2.3 demonstrate their ability to think analytically about actual works of art by designing and creating original work.

3. METHODS OF INSTRUCTION

- 3.1 Lecture
- 3.2 Presentation and discussion of visual material to include slides, videotapes, and where possible actual works of art
- 3.3 Assigned reading
- 3.4 Attendance at art shows
- 3.5 Demonstration

4. LEARNING ACTIVITIES

- 4.1 Observation and discussion of audiovisual materials
- 4.2 Assigned reading
- 4.3 Visitation to gallery exhibits
- 4.4 Designing of original work using drawings and models
- 4.5 Forming work using the techniques demonstrated in class
- 4.6 Gazing work to be fired

5. EVALUATION

- 5.1 Grades will be earned by an assortment of learning activities, exams, assignments, and participation.

6. STUDENT RESPONSIBILITIES
