COURSE DESCRIPTION

Advanced level paining course. Emphasizes exploration and development of personal process, style, expression, and concept.

- 1.1 Begin to explore and develop personal creative process and style
- 1.2 Learn to create a series of works unified by a self-defined thematic concept
- 1.3 Learn to translate ideas into a visually sophisticated form of personal expression

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 Demonstrate a coherent concept based upon exploration of personal style, expression, and content
- 2.2 Demonstrate growth of personal expression through use of media and content
- 2.3 Create a series of works based on a thematic concept
- 2.4 Create visually and intellectually challenging imagery through research, inspiration, and analysis

- 3.1 Lecture on student defined research topics and or writing assignments
- 3.2 Demonstrations on media and techniques as needed
- 3.3 Individual and class critiques

6. STUDENT RESPONSIBILITIES
