ARIZONA WESTERN COLLEGE SYLLABUS

ART 210 PRINTMAKING

Credit Hours: 3 Lec 2 Lab 4

PREREQUISITE: None (ART 101 or ART-111 Recommended)

COURSE DESCRIPTION

Introductory level printmaking course. Emphasizes basic relief, intaglio, monoprint, and monotype printmaking processes, techniques, matrices, and tools. B/W and color printing are explored

1. <u>COURSE GOALS</u>

- 1.1 Acquire a basic knowledge of historical printing processes, techniques, materials, and tools .
- 1.2 Learn to develop images on a variety of matrices and create multiples
- 1.3 Learn printmaking concepts and vocabulary

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 Demonstrate knowledge and use of printmaking tools, equipment, techniques, and materials
- 2.2 Develop relief and intaglio images through several states
- 2.3 Increase craftsmanship skills by pulling small print editions with consistency

- 3.1 Lecture and demonstrations on assignment topics, techniques, and equipment

6. <u>STUDENT RESPONSIBILITIES</u>
