ART 211 PRINTMAKING 2 Credit Hours: <u>3</u> Lec <u>2</u> Lab <u>4</u>

PREREQUISITE: ART 210

COURSE DESCRIPTION

Intermediate skill and conceptual relief and intaglio printmaking. Color intaglio, monoprinting and silk screen methods explored.

- 1.1 Exploration of historical printing processes.
- 1.2 Development of images using alternative techniques to direct media.
- 1.3 Develop conceptual aspects of creative expression in process-driven media.

- 2.1 Effectively use intermediate techniques of aquatint and mezzotint.
- 2.2 Develop color intaglio images.
- 2.3 Initiate a portfolio demonstrating conceptual and technical continuity.
