ART 251 SCULPTURE

Credit Hours: 3 Lec 2 Lab 4

PREREQUISITE: None

COURSE DESCRIPTION

Exposure to the concepts of sculpture by expanding the use of various media and by enriching visual thought to create expressive images.

1. COURSE GOAL

Prepare learners to create three-dimensional objects and investigate the experimental concepts of twentieth century sculpture.

2. OUTCOMES

Upon satisfactory completion of the course, students will be able to:

- 2.1 identify various sculptural techniques such as carving, casting, and construction.
- 2.2 select and use the appropriate technique for the project concept.
- 2.3 design form in three dimensions.
- 2.4 generate compositional ideas based on research and personal expression.
- 2.5 compose images that reflect an awareness of experimental twentieth century thought.

6. STUDENT RESPONSIBILITIES
