COURSE DESCRIPTION

Continued study of sculpture techniques with emphasis on design and individual student directions.

1. COURSE GOALS

- 1.1 Introduce and use intermediate sculpture techniques.
- 1.2 Develop an understanding of form as it applies to three-dimensional objects.

Upon satisfactory completion of the course, students will be able to:

- 2.1 identify various sculptural techniques such as carving, casting, and construction.
- 2.2 select and use the appropriate technique for the project concept.
- 2.3 design advanced forms in three dimensions.
- 2.4 generate compositional ideas based on research and personal expression.
- 2.5 compose images that reflect an awareness of experimental Twentieth Century thought in New Sculpture Media.

6. STUDENT RESPONSIBILITIES
