AUT 200 AUTOMOTIVE ELECTRICAL SYSTEMS

Credit Hours: 6 Lec 5 Lab 2

PREREQUISITE: None

COURSE DESCRIPTION

Introduction to electricity, storage batteries, hybrid high voltage systems, cranking motor fundamentals, regulator operations, ignition systems, automotive accessories and computer systems.

1. COURSE GOAL

Introduction to automotive electrical systems, electrical applications, electrical measuring devices, hybrid powertrains, and the diagnostics of electrical circuits using live vehicles, advanced technologies and simulations.

6. STUDENT RESPONSIBILITIES

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.

To comply with Federal Financial Aid regulations (34 CFR 668.21), Arizona Western College (AWC) has established an Attendance Verification process for “No Show” reporting during the first 10 days of each semester. Students who have enrolled but have never attended class may be issued a “No Show” (NS) grade by the professor or instructor and receive a final grade of “NS” on their official academic record. An NS grade may result in a student losing their federal financial aid. For online classes, *student attendance in an online class is defined as the following* (FSA Handbook, 2012, 5-90):
