AUT 209 AUTO ENGINE PERFORMANCE AND DIAGNOSIS

Credit Hours: 5 Lec 3 Lab 4

PREREQUISITE: AUT 200

NOTE: AUT 200 may be taken concurrently if pre-requisite has not been met.

COURSE DESCRIPTION

Emphasis is placed upon electronic engine management systems, exhaust gas analysis, including electronic ignition, emission control systems, customer relations, introduction to hybrid and green technology, and diagnostic repair procedures.

Diagnosis procedures, troubleshooting, advanced repair skills, and the diagnosis and repair of emission and electronic control systems with the use of advanced technological simulators and live vehicles.
