## **AUT 220 AUTOMOTIVE HYBRID FUNDAMENTALS**

Credit Hours: 2 Lecture 1.5 Lab .5

PREREQUISITES: AUT 200

### **COURSE DESCRIPTION**

An introduction to automotive hybrid, electric, and fuel cell systems; the benefits of these alternative technologies are explored and the proper safety practices suggested by vehicle manufacturers are identified.

#### 1. **COURSE GOAL**

This course is designed to provide a foundation for the continuing automotive student in understanding Hybrid, Electric and Fuel-cell vehicles using advanced technological simulation, and live vehicles. Student will also become familiar with the proper safety pre-cautions and maintenance procedures associated with these vehicles.
