BAR 102 Barbering Science and Theory

Credit Hours: 3 Lec 3

PREREQUISITE: None COREQUISITE: WEX 102

COURSE DESCRIPTION

This course provides the scientific foundation of barbering services, covering anatomy and physiology of hair, skin, and scalp, and applying this knowledge to treatments, haircutting, and shaving practices.

- 1.1. Connect biological science to barbering services.
- 1.2. Understand common skin, scalp, and hair disorders and their treatments.
- 1.3. Apply trade theory to safe and effective cutting, shaving, and treatment techniques.
