PREREQUISITE: None

COURSE DESCRIPTION

Students become familiar with the origin and history of broadcasting; understand the operation, structure, and organization of broadcasting in the United State – geographical, economical, statistical, and influential; become acquainted with the legal, social, educational, and artistic aspects of broadcasting; examine broadcasting codes and audiences.

To familiarize student with broadcasting

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will have:

- 2.1 A familiarization of the origin and history of broadcasting.
- 2.2 An understanding of the present operation, structure and organization of broadcasting in the United States.

- 3.4 Term paper
- 3.5 Student reports

4. <u>LEARNING ACTIVITIES</u>

- 4.1 Course lectures
- 4.2 Course audio visual presentations
- 4.3 Present oral and written reports, as assigned, on specific areas of broadcasting
- 4.4 Research, prepare and submit one term paper
- 4.5 Written guizzes on the field of broadcasting
- 4.6 The final written course examination

5. <u>EVALUATION</u>

Each student report, quiz, term paper and final examination has a point value. The student is given the points he earns on each student report, quiz, term paper and final examination

6. <u>STUDENT RESPONSIBILITIES</u>

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
