BHS 102 Behavioral Health Skills & Safety Lab

Credit Hours: 2, Lec 1, Lab 2

PREREQUISITE:

COURSE DESCRIPTION

In a lab setting, this course introduces the fundamental clinical techniques and safety measures performed by a behavioral healthcare specialist on-site. It covers facility, environmental, and patient safety as well as clinical and observational procedures such as vital signs and point of care testing. Observation and documentation of patients' behavior and physical condition are also included.

1. COURSE GOAL

Gain hands-on experience in fundamental safety measures and enhanced communication skills for building trust and rapport.

Upon satisfactory completion of this course, students will be able to:

- 2.1 Demonstrate fundamental clinical techniques and safety measures performed by a behavioral healthcare specialist
- 2.2 Demonstrate understanding of facility, environmental, and patient safety protocols
