BHS 105 Clinical Behaviors

Credit Hours: 2 Lec 2

PREREQUISITE:

COURSE DESCRIPTION

Overview of primary clinical behaviors frequently encountered by behavioral health personnel due to mental illnesses, substance use, violence or abuse, and grief or bereavement. This course covers a range of drug use problems, such as classifications of drugs, addiction theories, cultural views, and treatment techniques. The course also addresses domestic violence, including historical and contemporary causes and community resources, and information on dealing with the bereaved and others who have experienced traumatic loss.

- 1.1 Provide an overview of the primary clinical behaviors encountered by behavioral health professionals
- 1.2 Learn about the range of substance use problems, addiction theories, and treatment techniques
- 1.3 Learn about domestic violence, including its historical and contemporary causes, as well as community resources.
- 1.4 Develop an understanding of the grieving process and how to help those who are grieving.

- 2.4 Describe the grieving process and how to assist those who are grieving.
- 2.5 Describe the importance of diversity, equity, inclusion and belonging when working with clients from diverse backgrounds.

STUDENT RESPONSIBILITIES
