BIO 218 HUMAN PATHOPHYSIOLOGY

Credit Hours: 4 Lec 3 Lab 3

PREREQUISITE: BIO 201, BIO 202, and BIO 205

COURSE DESCRIPTION

Survey of disease processes that affect the body systems focusing on altered physiological mechanisms of cells and organ systems.

1. COURSE GOALS

In this course, students will:

- 1.1 Describe and explain how the major physiological mechanisms of the human body are altered by and contribute to disease processes.
- 1.2 Compare and contrast how pathology of diseases is encountered in the medical field.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 utilize medical terminology as it applies to the pathophysiological basis for alterations in health.
- 2.2 discuss the mechanisms of normal anatomic structure, physiological function, and biochemical processes within the human body.
- 2.3 describe the processes that lead to cell injury and describe responses for healing, including inflammation and fever.
- 2.4 identify the differences between normal physiological functioning and pathophysiological processes in the following systems of the human body: cardiovascular, digestive, respiratory, endocrine, nervous, reproductive, lymphatic, urinary, integumentary, skeletal and muscular.
- 2.5 apply critical thinking to analyze presentation of signs and symptoms based on underlying pathophysiological processes.
- 2.6 explain the basis for actions that could be taken to avoid pathophysiological states or conditions that could be implemented to reduce the risks of reoccurrence.
