CDL 104 General Driving and Testing

Credit Hours: 3 Lec: 6

PREREQUISITE:

CDL 103– Vehicle Control

COURSE DESCRIPTION

This course in the CDL certificate program is designed to provide final preparation for the student to pass the Arizona Commercial Driver License (CDL) exam. This exam must be passed before the student can become employed as a professional truck driver. The course will provide students with an in-depth review of all topics covered in previous courses including vehicle control, vehicle inspections, backing maneuvers, hazardous situations, and driving in various traffic conditions. In addition, the course will provide guidance on how to properly prepare for and take the three-part CDL test consisting of the pre-trip inspection, backing Maneuver skills, and General Drive test.

COURSE GOAL

1. Review and reinforce all previously learned material necessary for passing the CDL exam.
2. Provide guidance on preparing for and taking the three-part CDL test consisting of the pre-trip inspection, backing Maneuver skills, and General Drive test.
3. Ensure students are knowledgeable about all aspects of operating a commercial vehicle, including safety regulations, pre-trip inspections, driving techniques, and test procedures.
4. Prepare students to pass the Arizona Commercial Driver License exam and become licensed professional truck drivers.

OUTCOMES

1. Gain a thorough understanding of all topics covered in previous CDL courses, including vehicle control, backing maneuvers, hazardous situations, and safe driving techniques.
2. Learn about the specific requirements for taking the CDL Skills Test and Road Test in Arizona.
3. Develop a solid preparation plan for the CDL exam, including studying and practicing for the Skills Test and Road Test.
4. Gain proficiency at the Entry Level Drivers Training (ELDT) Behind the Wheel (BTW) Road skills outlined in part 380, app A of the Federal Motor Carrier Safety Regulation (FMCSR).
5. Certify proficiency of the BTW range and BTW Road skills on the Training Provider Registry.
6. Earn Arizona CDL by passing three-part CDL Test.

STUDENT RESPONSIBILITIES
