COURSE DESCRIPTION

Elements that influence physical, mental, emotional, and spiritual wellness; explores the impact of the wellness model on health care for self and others; effects of energy dynamics on bodywork.

1. COURSE GOAL

Prepares the student to recognize the impact of the wellness model on healthcare and how it impacts the healthcare practitioner; provides the tools for personal holistic wellness.

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 Perform a complete personal wellness assessment.
- 2.2 Explain energetic dynamics of human relationships.
- 2.3 Describe the mental, emotional, spiritual, physical and environmental factors that can influence wellness.
- 2.4 Use a variety of body/mind/spirit healing modalities as part of a self-healing process.
- 2.5 Explain how the wellness model contrasts with the disease model.
- 2.6 Explain how the wellness model impacts health care practitioners.
- 2.7 Explain the effects of energy dynamics on bodywork.
- 2.8 Demonstrate several energy clearing techniques.
- 2.9 Develop a personal exercise program that develops strength, stamina, coordination and control.
- 2.10 Explain how a variety of therapeutic activities can benefit a wellness personal program.
- 2.11 Demonstrate fundamental skills of a chosen activity with proper body mechanics and adherence to health and safety standards.
- 2.12 Perform fitness activities.

6. STUDENT RESPONSIBILITIES
