COURSE DESCRIPTION

Field Experience 220 will introduce students to a combination of community health and public health practice. This unique class will allow students to increase their knowledge and acquire skills that will allow them to work closely with community members, healthcare systems and public health professionals . By understanding how community health and public health roles interact, students will be able to develop a set of workforce skills.

1. COURSE GOAL

Develop a strong_knowledge of how community health, public health and healthcare systems interact; and how care coordination can help improve health outcomes of community served.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 Demonstrate strong communication skills (meeting notes, referrals, and client/patient follow-up).
- 2.2 Demonstrate how community and public health can help link and coordinate client's social and health care services.
- 2.3 Explain the relationship between health and social justice.
- 2.4 Identify target community's needs and challenges and evaluate needs to identify root causes to create proper response to needs.
- 2.5 Develop educational tools and or presentations on chronic diseases, mental health, domestic violence, opioids use and abuse, among other important topics for communities.
- 2.6 Document local referral resources and linkage to health care or social services.
- 2.7 Demonstrate group facilitation, support groups, individual one-on-one educational skills.
- 2.8 Explain how CHWs can increase health equity and reduce health disparities through referrals to other available service offered by community and health systems.
- 2.9 Demonstrate the importance of cultural humility in community health.
- 2.10 Respect client rights under the Health Insurance Portability and Accountability Act (HIPAA), and applicable agency rules.
- 2.11 Identify needs, challenges and barriers that communities face when accessing health and social services

- 6.6 Textbooks and materials: Students are required to bring notebook or loose-leaf book, pens, pencils, dictionaries, and purchase textbook required for class.
- 6.7 Arizona Western College students are expected to attend every class session in which they are enrolled.
