#### **COURSE DESCRIPTION**

Website design and development utilizing industry standard web design tools.

#### 1. COURSE GOAL

Using web design tools and basic HTML coding, students will design, create, and publish a website containing acceptable design standards which can be viewed successfully across multiple web browsers.

### 2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 identify hardware and software required to access the World Wide Web.
- 2.2 demonstrate knowledge of advanced Internet search techniques.
- 2.3 plan and design a small business website with multiple web pages that contains text and graphics, multimedia, tables, frames, and cascading style sheets.
- create a multi-page small business website with current Microsoft FrontPage and HTML software and using basic design principles including alignment, paragraphs, and proximity techniques.
- 2.5 demonstrate how to obtain a domain name for a website.
- 2.6 test a website using multiple web browsers and make necessary changes to a web page.
- 2.7 identify search criteria that will cause a search engine to promote this website.
- 2.8 publish (upload) a website to a host server computer.
- 2.9 complete an upgrade to a published website.
