PREREQUISITE: None

## **COURSE DESCRIPTION**

Basic principles and operator skills associated with the operation of a CNC milling machine.

## 1. COURSE GOAL

Develop the knowledge and basic skills needed to use and operate a CNC milling machine.

- 2.3 Take accurate measurements using a micrometer and or caliper to assess dimensional accuracy of parts production made with CNC milling and related machining equipment
- 2.4 Set up a CNC mill for part production.
- 2.5 Demonstrate ability to operate CNC mill to produce a part using a pre-set program.
- 2.6 Demonstrate ability to identify, change and replace machine tools and determine solutions for tooling wear or other issues related to accurate parts production and CNC equipment operation.
