CSC 127B INTRODUCTION TO COMPUTER SCIENCE 2

Credit Hours: <u>4</u> Lec <u>3</u> Lab <u>2</u>

PREREQUISITE: CSC 127A or EGR 123

COURSE DESCRIPTION

This course is a continuation of CSC 127A or EGR 123, focusing on advanced CSC and software engineering concepts using Java and other programming languages.

1. COURSE GOAL

Students will learn the fundamentals of advanced programming concepts, enabling the students to solve advanced real-world problems from a computer science, software engineering and programming perspective.

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 design programs that implement advanced data structures and data structure organization concepts
- 2.2 create programs that implement various search algorithms
- 2.3 create programs that implement GUIs, inheritance and polymorphism
- 2.4 implement recursion and iteration in programs
- 2.5 design programs that work with files and implement input/output operators and serialization
- 2.6 create programs that implement Lambdas and streams in Java programs
- 2.7 implement generic classes and methods in Java program
- 2.8 use JDBC to access databases
- 2.9 use development tools like JShell and JavaFX Scene Builder to create interactive and graphical Java programs
