CSC 210 HUMAN COMPUTER INTERACTION

Credit Hours: 4_ Lec 3_ Lab _2_

PREREQUISITE: CSC 127A or EGR 123

COURSE DESCRIPTION

The course focuses on computer human interaction theory and designing graphical user interfaces that ensure effective human computer interaction with computers, websites and other technologies.

1. COURSE GOAL

Students will learn and apply the theory and practice behind researching and designing graphical user interfaces that meet user specifications in software applications, web applications and other technologies.

- 2.2 apply conceptual interaction models, paradigms, theories and frameworks
- 2.3 explain cognitive aspects and social interactions in computer human interaction
- 2.4 implement interaction design as an iterative process, including cycles of observation, ideation, prototyping, and evaluation
- 2.5 apply research findings to the graphical user interface design process
- 2.6 establish interface requirements in the graphical user interface design process
- 2.7 implement user-friendly graphical user interfaces in software applications and websites
- 2.8 evaluate usability outcomes of graphical user interfaces students design
- 2.9 explore future innovations, and the ethical and social implications of future innovative technologies
