CSC 215 INTRODUCTION TO ARTIFICIAL INTELLIGENCE

Credit Hours: <u>4</u> Lec <u>3</u> Lab <u>2</u>

PREREQUISITE: CSC 127A or EGR 123

COURSE DESCRIPTION

This course is an introduction to artificial intelligence (AI), focusing on machine learning, agents, problem solving, first order logic, classical planning, knowledge representation, natural language processing, perception, robotics, sensors, augmented reality, virtual reality and mixed reality.

1. COURSE GOAL

Students will learn and apply artificial intelligence concepts, enabling students to develop AI software for smart applications, robotics, and augmented, virtual and mixed reality devices.

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 create AI programs using Lisp, Prolog, Java, Python and other AI capable languages
- 2.2 design algorithms to implement in AI programs
- 2.3 demonstrate knowledge of machine learning, intelligent agents, and logical agents
- 2.4 describe problem solving, classical planning and knowledge representation in AI
- 2.5 implement first order logic in AI problem solving processes
- 2.6 apply natural language processing and perception to robotics and other AI systems
- 2.7 demonstrate sensor planning and programming for smart devices
- 2.8 differentiate between augmented reality, virtual reality and mixed reality
- analyze current and future advancements in AI, robotics, expert systems, smart devices, augmented reality, virtual reality, mixed reality and other AI technologies.
