CSC 252 COMPUTER ORGANIZATION

Credit Hours: 3 Lec 3

PREREQUISITE: CSC 127A or EGR 123

COURSE DESCRIPTION

This course is an introduction to computer organization, focusing on machine organization, hardware concepts, machine operations, computer architecture and assembly language concepts and programming.

1. COURSE GOAL

Learn and apply the theory and practice behind computer organization and assembly programming concepts.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 describe computer organization concepts
- 2.2 design assembly language programs
- 2.3 explain data representation in processors
- 2.4 implement arithmetic operations in processors
- 2.5 describe the rationale behind memory organization and how caches operate
- 2.6 demonstrate knowledge of multi-core processors and architectures
- 2.7 apply knowledge of logic blocks including NOT, AND, OR, XOR, NAND, and NOR gates
- 2.8 demonstrate an understanding of CPU processes including scheduling, threading and interrupts
- 2.9 describe system deadlock and the steps for deadlock prevention and resolution
- 2.10 define data processing hardware interactions

6. STUDENT RESPONSIBILITIES
